Guidelines for Exhibitors at Sean's Run Weekend – April 28 & 29, 2018

- 1. Submit a Registration Form** – by one week before Sean's Run Weekend
- 2. Set Up** –Saturday, 4/28, between 11 AM & 1 PM, or Sunday, 4/29, by 9 AM
- 3. Break Down** – 12 Noon, Sunday, 4/29
- 4. Parking** – only cars that have been issued an EXHIBITOR PASS will be allowed to park in the HS parking lot. Cars with a PASS may enter the parking lot until 10:30 AM.
- 5. Departing** – cars may not leave the parking lot between 10:30 AM and 1:15 PM.
- 6. T-Shirts** – each organization that exhibits will be provided 2 complimentary entries to participate in the 5K or Meghan's Mile. Submit the entry forms and pick up T-shirts at the event.
- 7. Exhibit Areas – note, there is no fee to exhibit**

A. Prevention Education Expo – inside the gymnasium (see website: <http://www.seansrun.com/event16.htm>)

Open to: Organizations or community groups with exhibits designed to advance the mission of the Sean's Run Organizing Committee:

- Educating young people and their parents about the potentially fatal consequences of underage drinking and impaired driving,
- Encouraging young people to try positive alternatives and refrain from the use of alcohol, other drugs and tobacco,
- Underscore the importance of wearing seat belts
- Other issues/programs that promote healthy lifestyles and welfare of young people.

Exhibit space – 10 X 10 feet, includes 8-foot table to display information and distribute materials.

Open to:

a) Sean's Run Weekend Sponsors

Examples include: Bicycle shop displaying bikes, Running Shoe store displaying shoes and apparel, Register Star/ Chatham Courier signing up subscribers

Exhibit Space – 10 X 10 Feet, exhibitor must bring own table, may set up tent in space, may display banner not to exceed 3 X 3 feet

b) Nonprofit groups that promoting running, walking, bicycling and Zumba

Examples include: Kinderhook Runners Club, League of American Bicyclists, Road Runners Club of America, Bike Helmet Safety organization, Rail Trail and Land Conservancy Bike Trails
